SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation: If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. Do not use mouth-to-mouth method if victim ingested the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. If symptoms persist or if the victim feels unwell, seek medical attention.

Eyes: Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to do, after first 2 minutes and continue rinsing. Seek immediate medical attention, preferably from an ophthalmologist.

Skin: Flush skin with large amounts of water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing and shoes before reuse. Seek medical attention for chemical burns. If irritation persists or if the victim feels unwell, seek medical attention.

Ingestion: Rinse mouth with water if the victim is conscious. Remove dentures if present. Give 1 - 2 cupfuls of milk or water to drink if victim is conscious, alert and able to swallow. DO NOT induce vomiting unless directed to do so by medical personnel. Vomiting may occur spontaneously. To prevent aspiration of material into the lungs, lay the victim on one side with the head lower than the waist. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek immediate medical attention.

4.2 Most important symptoms and effects, both acute and delayed

Potential health symptoms and effects

Eyes: Causes severe eye irritation. Symptoms may include redness, swelling, pain, tearing, burns and blurred vision. Prolonged contact with the eye may cause permanent eye damage or vision impairment. Vapor or mist can cause severe eye irritation.

Skin: Causes skin irritation with localized redness, itching and discomfort. Prolonged and repeated contact with unprotected skin may cause drying and cracking of the skin or dermatitis.

Inhalation: Mist or vapor can cause of the respiratory system. Symptoms may include irritation of the nose, throat, headache, cough, sore throat, chest tightness and breathing difficulty. Prolonged inhalation may cause burns to the respiratory tract and absorption of harmful amounts of acetic acid through the lungs. This material is not expected to be a respiratory hazard when used as directed.

Ingestion: Causes irritation of the gastrointestinal tract with abdominal pain, nausea, vomiting and diarrhea

Chronic: Persons with pre-existing skin disorders or impaired respiratory function may be more susceptible to the effects of this material. Prolonged and repeated contact with unprotected skin may cause drying and cracking of the skin or dermatitis.

SECTION 5 - FIRE FIGHTING MEASURES

5.1 Extinguishing media

Suitable methods of extinction: Use extinguishing media suitable for the surrounding fire.

5.2 Special hazards arising from the substance or mixture

Closed containers may rupture due to the buildup of pressure when exposed to extreme heat. During emergency conditions overexposure to decomposition products may cause a health hazard. Symptoms may not be immediately apparent or may be delayed. Obtain medical attention.

5.3 Advice to firefighters

Full protective equipment including self-contained breathing apparatus should be used. SECTION 6 - ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Evacuate non-essential personnel. Wear appropriate protective clothing and equipment designated in Section 8.2. Ventilate the area. Remove all sources of ignition. NO SMOKING. Clean up spills immediately. Spills create a slip hazard.

6.2 Environmental precautions

Avoid dispersal of spilled material or runoff and prevent contact with soil and entry into drains, sewers or waterways. Use water sparingly to minimize environmental contamination and reduce disposal requirements.

6.3 Methods and materials for containment and cleaning up

Approach spill from upwind direction. Cover drains and contain spill. DO NOT flush spills down the drain. Cover spill with a large quantity of non-combustible, inert absorbent. Do not use combustible materials such as sawdust. Collect material and place into an approved container for proper

disposal. Observe possible material restrictions (Sections 7.2 and 10.5). Clean contaminated area with soap and water. Do not allow material or runoff from rinsing contaminated areas to enter floor drains or storm drains and ditches that lead to waterways. Dispose of material via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

7.1 Precautions for safe handling

Keep container tightly closed when not in use. Protect containers from physical damage. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Containers are hazardous when empty as they contain product residues. Use appropriate containment to avoid environmental contamination. Ventilate closed areas. Keep locked up and out of reach of children.

8.1 Control parameters

8.2 Exposure controls

Engineering measures: Technical measures and appropriate working operations should be given priority over the use of personal protective equipment. Use adequate ventilation. Local exhaust is preferable. Refer to Section 7.1.

Individual protection measures: Wear protective clothing to prevent repeated or prolonged contact with product. Protective clothing needs to be selected specifically for the workplace, depending on concentrations and quantities of hazardous substances handled. Where risk assessment shows air-purifying respirators are appropriate use a half-mask respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU). Follow OSHA respirator regulations found in 29 CFR 1910.134 or European Standard EN 149.

Environmental exposure controls: Do not empty into drains.


