- Methods for cleaning up : Sweep spilled substances into containers if appropriate moisten first to prevent dusting. Use vacuum cleaner to collect spilt material. Avoid raising dust. Do not allow dust to accumulate on surfaces and equipment. Dust clouds are sensitive to ignition by electrostatic discharge. Earth may be shoveled to contain spillage and to avoid contamination of sewers and watercourses.
