Methods and Material for Containment and Cleaning Up

Measures for Cleaning / Collecting: Contain the source of the spill if it is safe to do so. Eliminate possible ignition sources (e.g., heat, sparks, flame, impact, friction, electricity), and follow appropriate grounding procedures. Collect spilled material by a method that controls dust generation. Use non-combustible absorbent material to wipe up spill and place in a sealed container for disposal.
